STRATEGIC OVERVIEW

I. Mission Statement

- Ensure that the education system fosters a knowledge-oriented, cohesive, inclusive and productive society
- Promote a holistic and inclusive education that makes learners upholders of values and grow into resilient and globally-minded citizens
- Create an enabling environment for technical and higher education, science and technology development
- Equip learners with innovative, cutting-edge knowledge and deep research skills for increased competence in a dynamic work environment
- Sustain existing and motivating conditions towards the recognition of Mauritius as a regional and continental Education Hub

II. Current Situation & Challenges

- A Grant-in-Aid scheme is being worked out to operationalise the free pre-primary education policy.
- In 2022, pupils of Grade 5 and students of Grades 10 and 12, upon request of their responsible parties, were allowed to sit for the Primary School Achievement Certificate (PSAC) Assessment, and the Cambridge School Certificate and Higher School Certificate examinations, respectively.
- As from 2023, the school calendar was restored, starting in January and ending in November.
- An additional 190 Support Teachers have been recruited, thus bringing the total to 489, to strengthen the Early Support Programme to provide remedial support to pupils encountering learning difficulties.
- Specific programmes like Natation Scolaire, After School Sports and Performing Arts were introduced as part of the whole-person development goal of the education reform. The Social and Emotional Well-being of learners is also being catered for.
- In 2023, for the first time, two scholarships were offered to the most meritorious boy and girl on the Economics side under the Sir Anerood Jugnauth National Scholarship Scheme and two scholarships to the best performing boy and girl having opted for the HSC Professional.
- Kreol Morisien has been successfully rolled out to Grade 11 in 2023, following its introduction in Grade 10 in 2021. Students will sit for the first examinations in October/November 2023 and will be awarded a certificate by the University of Mauritius.
- Mandatory pre-service training is now an entry requirement in the secondary sub-sector to improve the professionalisation of teachers.
- The Institute of Technical Education and Technology (ITET) is being operationalised to provide for high level technical and technology education.
- To improve decentralised access to high quality technical education, Polytechnics Mauritius Limited expanded its activities through the opening of a new campus in the South of the island.

- The University of Mauritius is for the first time listed in the Times Higher Education World University Rankings 2023.
- Some 100 projects have been funded in the higher education sector under the Research Fund for a total value of around Rs 150 million.
